

Veterinarians Warn of Unusual Strain of Kennel Cough in Dogs

Veterinarians in North Carolina have reported a high number of kennel cough cases this fall. The strain appears to be highly contagious and causes a dry hacking cough. The traditional *Bordetella* vaccine is not effective against this strain which has been found to be caused by *Mycoplasma* spp.

Symptoms include cough, nasal and ocular discharge, lethargy and fever. Like Bordetella, this strain of kennel cough is highly contagious. Most dogs continue to have normal attitude or maybe mild lethargy. However, some dogs can progress to pneumonia and become severely ill. The infection is usually self-limiting and lasts 7-10 days. Many pets can be treated with supportive care at home.

More severe cases usually occur in dogs with underlying medical conditions or compromised immune systems.

Just like their human counterparts, the best way to avoid infection is social distancing. Owners are being told to avoid dog parks, doggy day care, grooming appointments or other large gatherings of dogs if kennel cough is prevalent in their area. It is not currently known how widespread this strain will be. Currently it appears to have been limited to the southeast, but some veterinarians in Oregon have reported cases as well. With dogs traveling as companions on airlines and family vacations more often now, it is much easier for a disease like this to spread across the country.

New Research Has Found That Feeding Cats One Large Meal A Day May Help Control Hunger Better Than Feeding Them Several Times A Day

Research published in PLOS One by nutritionists at University of Guelph suggest that feeding cats just one meal a day could reduce hunger. Cats fed one meal a day seemed more satisfied and less likely to beg. Researchers suggest this could prevent weight gain and reduce the number of overweight cats.

These findings are contradictory to what most veterinarians have been telling cat owners regarding feeding frequency. It was previously thought that cats needed several meals a day for optimum nutrition. This study is the first to analyze feeding frequency and its effects on appetite suppressing hormones, energy expenditure and physical activity.

The study involved eight cats, all of healthy weight and under the age of five. Cats were fed one meal in the morning or were fed the same total amount divided into four smaller meals. Each cat was exposed to both schedules for three weeks each. Researchers recorded physical activity, daily food intake and weekly weight measurement. Cats fed four meals a day showed higher physical activity, but did not expend any more energy than cats fed once daily. Weight did not change for either group during the study.



Cats that were fed one meal a day had higher post-meal levels of appetite regulating hormones and lower fasting respiratory quotient consistent with burning fat stores. These cats also had more increased in blood amino acids which translates into more protein for muscle mass.

Researchers feel that once meal a day is more consistent with big cats in the wild who make a big kill and then fast until their next kill. Researchers acknowledge this feeding style may not be appropriate for every cat and would like to conduct longer studies.

New Study Investigates Use of Meloxicam & Robenacoxib in Cats with Chronic Kidney Disease

The WSAVA Global Pain Council (WSAVA-GPC) evaluated several studies to determine the safety of using NSAIDs in cats with chronic kidney disease and concurrent chronic pain conditions. Chronic kidney disease (CKD) is a common ailment of older cats affecting up to 40% of cats over the age of 10 and 80% of cats over 15 years of age. Many of these cats also suffer from painful conditions such as osteoarthritis, periodontal disease and cancer. It is estimated that 70% of cats with CKD also suffer from osteoarthritis, yet non-steroidal anti-inflammatory drugs (NSAIDs) are generally contraindicated in animals with CKD.


NSAIDs work by inhibiting cyclooxygenase enzymes (COX) in cells. COX enzymes are necessary for biosynthesis of prostaglandins that play a role in renal perfusion and regulation. Thus, it has been speculated that NSAIDs could contribute to renal toxicity in renal compromised patients.

Researchers found long-term NSAID therapy to be safe in cats with osteoarthritis for 6 months. During this study, researchers saw no difference in serum creatinine levels between the meloxicam and the control group. Following this study, researchers set out to determine if NSAIDs could be safely administered to cats with CKD and found that NSAIDs can be administered safely to cats with stable CKD.

WSAVA-GPC suggests that stable CKD indicates

a stable patient with minimal changes in body weight and creatinine for at least 2 months and controlled concurrent conditions. Cats at IRIS stages 3 and 4 are not typically studied in NSAID research. It is recommended that the lowest effective dosage be used and may be titrated up or down based on patient response. The average dose of meloxicam in one retrospective study was 0.02mg/kg.

It is important to note that not all CKD cats are candidates for NSAID therapy. The clinician should take into account the pet's overall health and have a detailed discussion with the owner of the risks vs. benefits of NSAID administration. In addition, it is important to educate owners on the signs to look for when administering NSAIDs to renal patients. Do not forget to take into account other treatment modalities that are





Organization Seeks to Diversify Veterinary Workforce

Purdue University's College of Veterinary Medicine has developed an organization to help diversify the veterinary workforce. The League of VetaHumanz, in collaboration with 18 member institutions, will highlight role models in the veterinary field to provide support to underserved youth wishing to pursue veterinary careers. The League represents academia, practice, research, government and industry. Purdue says it plans to provide veterinary students with resources to engage community youth after graduation.

Dr. Sandra San Miguel, whose superhero name is Pink Phoenix, is the founder of the League of VetaHumanz and the associate dean for engagement in Purdue University's College of Veterinary Medicine. In addition to active role models, the organization is planning to provide resources to children who do not have access to in-person role models so that they can learn about a veterinary role model and have a veterinary-related activity at home. The website also offers access to free video role models, an online game and books about veterinary medicine.

VetaHumanz is meant to resemble the term metahumans from the DC Comics universe, who are humans with superpowers. The website defines VetaHuman as "A human being with superpowers who protects animal and public health; synonym: veterinarian. Role models with the organization are identified as superheroes.

The league is supported by a five-year grant from the Science Education Partnership Award program of the National Institute of General Medical Sciences. Purdue's College of Education will evaluate the impact of the league by studying changes in attitude toward the veterinary profession, knowledge of veterinary science and the impact of live and virtual role modeling.

Aquamation

Aquamation, also known as alkaline hydrolysis, is marketed as a greener process of body disposal. The process uses electricity, water and lye to break down organic materials. Because it does not rely on fossil fuels like traditional cremations, Aquamation has a tenth of the carbon footprint.

Aquamation is becoming an increasingly popular form of cremation and has been approved for pet remains in all 50 states. The process for humans is more limited and only approved in 21 U.S. states at this time.

The process involves creating an alkaline environment in water under high pressure. The time it takes varies based on the operating temperature of the equipment but ranges from 8-20 hours. Temperatures range from 200-300 degrees Fahrenheit. All organic material is broken down to its most basic building blocks so that no proteins or DNA remain.

In comparison, flame cremation occurs at temperatures of 1600-1800 degrees Fahrenheit and takes 1-3 hours to complete. The cost for Aquamation ranges from \$150-400 for dogs. The remains are usually processed into a powder for placement into an urn, very similar to traditional cremation.

Aquamation services are available locally through Heartland Pet Aquamation in Kansas City.
